IMPORTANT REMINDER

We develop Medical Policies to provide guidance to Members and Providers. This Medical Policy relates only to the services or supplies described in it. POLICY

INDICATIONS

The indications below including FDA-approved indications and compendial uses are considered a covered benefit provided that all the approval criteria are met and the member has no exclusions to the prescribed therapy.

FDA-Approved Indications

Adult patients with extensive stage small cell lung cancer (ES-SCLC) with disease progression on or after platinum-based chemotherapy.

All other indications are considered experimental/investigational and not medically necessary.

COVERAGE CRITERIA

Small Cell Lung Cancer

Authorization of 12 months may be granted for treatment as a single agent **when one of the following is met:**

- **Member has extensive stage small cell lung cancer (ES-SCLC) with disease progression on or after platinum-based chemotherapy.**
- **The requested medication will be used for treatment of brain metastases in small cell lung cancer.**

CONTINUATION OF THERAPY

Authorization of 12 months may be granted for continued treatment in members requesting reauthorization for an indication listed in the coverage criteria section when there is no evidence of unacceptable toxicity or disease progression while on the current regimen.

APPLICABLE TENNESSEE STATE MANDATE REQUIREMENTS
