The National Committee for Quality Assurance (NCQA) has established specifications that impact Centers for Medicare & Medicaid (CMS) Star measures for patients with advanced illness and frailty. Additional exclusions to these measures were made because the services recommended in the original definition may not benefit older adults with advanced illness limiting their ability to receive certain treatments.

Advanced illness codes must be submitted in the **current (measurement) year or the prior year** to exclude the patient from the impacted Star measures. **Frailty** codes must be submitted in the **current (measurement) year** in order to exclude the patient from the impacted Star measures. Please see the table below for specific measures impacted by these diagnoses.

Patients age 66 and older can be excluded if they have both advanced illness and frailty

- › Breast Cancer Screening (BCS)
- › Colorectal Cancer Screening (COL)
- › Controlling Blood Pressure (CBP)
- › Hemoglobin A1c Control for Patients With Diabetes (HBD)
- › Eye Exam for Patients With Diabetes (EED)
- › Kidney Health Evaluation for Patients With Diabetes (KED)
- › Osteoporosis Management in Women Who Had a Fracture (OMW)
- › Statin Therapy for Patients with Cardiovascular Disease (SPC)

Patients age 81 and older can be excluded with frailty alone

- › Controlling Blood Pressure (CBP)
- › Osteoporosis Management in Women Who Had a Fracture (OMW)
- › Kidney Health Evaluation for Patients With Diabetes (KED)



Helpful Tips

To qualify for advanced illness exclusion, the patient must have **at least one** of the following:

- › Two claims on different dates of service with an advanced illness code
- › One filled prescription for a dementia medication

To qualify for frailty exclusion, the patient must have **at least two** claims on different dates of service with a frailty diagnosis or treatment code.



Frailty conditions and their accompanying ICD-10 codes are often not captured during routine office visits. Annual wellness exams offer a yearly opportunity to address gaps in care, as well as possible exclusions.

Common frailty conditions that can exist in the senior population include:

- › History of falling (Z91.81)
- › Weakness (R53.1)
- › Muscle weakness (M62.81)
- › Other malaise (R53.81)
- › Difficulty in walking (R26.2)

Best Practices for Advanced Illness and Frailty Exclusions

- › Consider implementing a process to identify and add appropriate Advanced Illness and/or Frailty diagnoses for patients with upcoming appointments and/or during PAF completion.
- › If the documentation exists for an Advanced Illness and/or Frailty diagnosis from a previous visit, you may bill CPT® **99499** for the date of service of the previous visit and include the applicable Advanced Illness and/or Frailty code.
